It does not support routine work of the Government of Ukraine that is normally managed by the civil service. To do this, PRSM:

- Ensures transparent **recruitment** of human resources;
- Manages the contracting and payment of human resources;
- Provides financial reports for donors;
- Monitors initiatives for results.
