Reforms Delivery Office of the Cabinet of Ministers of Ukraine (RDO) – an advisory body that provides comprehensive support to the Cabinet of Ministers of Ukraine, supporting reforms from problem analysis and developing an idea and mechanism for its implementation to monitoring the effectiveness and communication of change.

RDO is part of the Ukraine Reform Architecture¹ supported by EBRD and financed by the Ukraine Stabilization and Sustainable Growth Multi-Donor Account (MDA).

Key deliverables

- Provided proposals to the Medium-Term Priority Actions Plan for the Government until 2020, approved by Order No. 1133-r as of September 9, 2020.

3.1. Reform Support Team at the Ministry of Finance of Ukraine





Reform Support Team at the Ministry of Finance of Ukraine is a team of experts that assists the Ministry in the development of a sound and efficient public finance management system. This covers both the broader Public Finance Management Reform and the narrower Tax and Customs Reforms, State-Owned Banks Reform, Corporate Governance Reform in the Energy Sector, Cooperation with IFIs, Public Administration Reform, etc.

Key deliverables

Public Administration Reform & Capacity Building of the Ministry

• Supported the development of reliable, secure IT infrastructure of the Ministry, incl. the launch of the system of electronic document circulation in the Ministry and project management support during IT Centralization.

Customs reform

- Made a significant contribution to the reform of the State Fiscal Service, incl. inputs to the Conceptual directions for reforming the system of bodies implementing state customs policy and the Action Plan for their implementation, the Strategy of Integrated Border Management until 2025, and the Action Plan for its Implementation for 2020-2022.

Key deliverables

Financing Reform and Road Network Renewal and Road Construction Governance

- Provided support to Ukravtodor in the increase in financing of the State Road Fund and the efficiency of funds use through the development of the legislative framework for the actual implementation of reforms.
- Facilitated Ukravtodor with the introduction of medium-term budgetary planning in the road industry.

Decentralization Reform

- Made analyses on municipal roads and financing and management of municipal and local roads. Developed proposals for the creation of local road funds.
- Prepared draft legal acts on further decentralization of the road industry, incl. the transfer of territorial roads to the local level.

Road Transport Safety Reform

Reform Support Team of the Ministry of Energy and Environment Protection of Ukraine is a group of professionals funded on a temporary basis by donors that provides targeted technical support and assists the Ministry in the design and implementation of priority reforms through capacity-building and improvement of coordination within the Ministry in the field of environment protection.

Key deliverables

Public Administration Reform (in the field of environmental protection)

- For the purpose of increasing the institutional capacity of the Ministry, a functional review of 15 structural divisions of the Ministry was finalized.
- Developed the Ministry's Strategy for HR management, a new structure of the Ministry, and respective draft regulatory acts.
- Prepared recommendations on the redistribution of functions in the area of environmental policy implementation.

E-Governance and Anti-Corruption

- Provided support to the Ministry with the development of draft legal acts and technical requirements for the creation of a system of electronic document circulation in the Ministry.
- Ensured development of the "Cabinet of the subsurface user" and drafting of technical requirements for the "Cabinet of the eco-inspector" and GIS for waste management.

Environmental Supervision, Monitoring and Liability System

Key deliverables

Restructuration and Human Resource Management

- Held the functional review of the Customs, developed proposals on the organizational structure, and legal documents on functions of structural units of the Service drafted.
- Introduced new HR business processes. Analyzed with the current business processes within the Customs work.
- Ensured support with recruitment of staff and with the development of legal documents on selection of specialists for public service positions.
- Provided support with development of the KPI system and its linkage to staff's rewards and recognition.

Functional Customs Changes

- Analyzed all customs procedures and processes for the development of propositions for their improvement.



are not currently covered by the provisions of the Tax and Customs Codes of Ukraine regarding exemption from import duty and tax for added value;
